TERMS & CONDITIONS

The parties herein agree as follows:

- 1) Pet Sitter is authorized to perform care and services as outlined on this contract. Pet Sitter is also authorized to seek emergency veterinary care with release from all liabilities related to transportation, treatment, and expense. Should specified veterinarian be unavailable, Pet Sitter is authorized to engage the services of the veterinarian of their choice. If client can not be contacted in a timely manner, Pet Sitter is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse Pet Sitter/Company for expenses incurred, plus any additional fees for attending to such emergency, as well as expenses incurred for any other home/pet supplies needed.
- 2) In the event of inclement weather or natural disaster, Pet Sitter is entrusted to use best judgment in caring for pet(s) and home. Pet sitter/company will be held harmless for consequences related to such decisions.
- 3) I (or my homeowner's insurance) will be responsible for any injury (i.e. pet bite, scratches requiring medical attention) to Pet Sitter due to my pet(s) or condition of premises.
- 4) This company, its employees and independent contractors agree to provide the services stated in this contract in a reliable, caring, and trustworthy manner. In consideration of these services and as an express condition thereof, the Client expressly waives and relinquishes any and all claims against said Pet Sitter/Company except those arising from negligence or willful misconduct on the part of the Pet Sitter.
- 5) I understand that this contract also serves as an invoice and I take full responsibility for prompt payment of fees. All unanticipated times and expenses spent during responsible completion of pet care duties will be paid upon receipt of additional invoice. A finance charge of 18% will be added to unpaid balances after thirty (30) DAYS. A handling fee (\$20) will be charged to all returned checks. One half deposit is required on lengthy assignments and clients with a history of late payment will be required to pay before services are rendered.
- 6) I further authorize this contract to be valid approval for future services permitting you pet sitting service to accept my telephone reservations for service and enter my promises without additional signed contracts or written authorizations.
- 7) In the event of personal emergency or illness of pet sitter, client authorizes pet sitter to arrange for another qualified person to fulfill responsibilities as set forth on this contract. Client will be notified in such a case.
